I. INFORMATION

Please be informed that under Article 21 of the GDPR Regulation (Regulation (EU) 2016/679 of the European Parliament and of the Council), you have the right to **object at any time to the processing of your personal data in our Company** for reasons relating to your own situation, if our data processing is based on the legal bases of Art. 6 (1) (e) or (f) of the GDPR Regulation, i.e. the fulfilment of the **public interest** task or the basis **of a legitimate interest**.

In such cases, the controller **may no longer process** the personal data **unless** the controller proves that the processing is justified by compelling **legitimate reasons** which **take precedence** over the interests, rights and freedoms of the data subject, or related to the establishment, exercise or defence of legal claims.

Where personal data are processed for scientific and historical research purposes or for statistical purposes, the data subject shall have the right to object to the processing of personal data relating to him for reasons relating to his situation, **unless** the processing is necessary for the performance of a task carried out **in the public interest**.

Where personal data are processed for **direct marketing** purposes, the data subject shall have the right to object at any time to the processing of personal data relating to him for that purpose, including profiling, insofar as it relates to direct marketing.

If the **data subject** objects to the processing of personal data for the purposes of **direct marketing**, the personal data may **no longer be processed** for that purpose.



II. VERIFICATION OF IDENTITY

Depending on the **type of data** managed, you may need to verify your identity, because here too we follow the **principle of data saving!**

With this verification, **we ensure that your data is protected so that we do not give it to unauthorized persons or ask you for more information** than is necessary for unambiguous identification!

Please note that until your identity is verified in an appropriate form, our Company will not be able to comply with your request.

We inform you that the purpose of this data processing is to verify and check the identity necessary for the evaluation of the application, which is **processed until the end of the application process.**

- **In writing, in the case of a request by post:** By completing this form and sending you information confirming your identity. It is important that you **send your letter as REGISTERED to the** postal address specified in our *Privacy Notice!*
- In the case of a **personal** request: Complete this form and having information and documents confirming your identity.
- In case of a request sent **by email**, please send this form printed, signed and scanned, as well as the information confirming your identity in a body of letters or as an attachment to the email address specified in our *Privacy Notice*.
